

### The Great British Cup (Large Clubs Open)

- 1.1 Each club must submit 15 PDI – ONLINE.
- 1.2 Natural History PDI are NOT permitted and, if included, the judges will be asked to assess them strictly as pictorial PDI, not as Nature. . Please comply fully with this rule.
- 1.3 No photographer may have more than 4 PDIs and there must be at least 6 photographers in the entry.

### The Great British Cup (Small Clubs Open)

- 2.1 Each club must submit 10 PDI – ONLINE.
- 2.2 Natural History PDI are NOT permitted and, if included, the judges will be asked to assess them strictly as pictorial PDI, not as Nature. Please comply fully with this rule.
- 2.3 No photographer may have more than 4 PDIs and there must be at least 4 photographers in the entry.

### The Great British Cup (Nature)

- 3.1 Each club may submit a minimum of 3 and a maximum of 21 PDI – ONLINE.
- 3.2 The Winning Club will be decided on the aggregate of the 10 highest scoring PDIs. If a Club has entered fewer than 10 PDIs it cannot qualify for the Club trophy. Individual awards will be available at the discretion of the judges including “PAGB Nature Photographer of the Year” based on an individual’s best 3 PDIs. You are encouraged to enter even if you have only one Nature photographer in your Club. The judges will recognise all aspects of Nature.
- 3.3 No photographer may have more than 3 PDIs.
- 3.4 Our definition of Natural History is given at Appendix One.
- 3.5 The GB Cup is not a Wildlife Competition but photographs which comply with our Wildlife definition and which are marked (W) may be considered for a Wildlife Individual Award.



## EAST ANGLIAN FEDERATION OF PHOTOGRAPHIC SOCIETIES



Recently the EAF held an advisory day for the Awards for Photographic Merit, supported by the PAGB APM team of Rod Wheelans, Richard Speirs and Gordon Jenkins), along with Peter Cheetham and our own Andy Hanson who all acted as assessors for the day. A total of 38 applicants and 23 observers/potential applicants attended.

The first session, conducted by Rod, explained in detail how applicants' images are assessed at Adjudications. Display stands held about 45 prints from recent Adjudications and applicants were asked to act as judges, placing these prints according to the scores they thought they might have achieved – from 12 points to 30 points. This proved to be a very popular way of enabling the applicants to interact whilst assessing the prints on display and the audience did a much better job ordering them than they had expected.

In the afternoon, applicants were able to have their own selection of images assessed with advice given on a one-to-one basis about their chances of success and which images could be improved. Most of those attending felt enthused and motivated to move forward in pursuit of distinctions although, inevitably, one or two realised that more work needed to be done before they could be ready to apply.

Overall, it was adjudged to be a very successful day. Everyone agreed that their chances of achieving a PAGB Award could only be improved by such advice and there have already been requests for more such sessions. The EAF will stage a smaller event early in the New Year, when those whose applications have been accepted so far will be able to have their proposed selections of images finally checked before being sent off for assessment at the next PAGB Adjudication Day.



It came as no surprise that on 24 October representatives from all 15 Federation had arrived early and that the meeting started 15 minutes ahead of schedule. It was a **Judges Organisers' Seminar** - an exploratory meeting to look at, and exchange views about how we find, train and look after our judges.

The meeting was well organised by Howard Tate and chaired by Roger Parry. The PAGB was also represented by Rod Wheelans and the PAGB President, Roy Thomas. The agenda seemed to include every conceivable subject and everyone was given plenty of opportunity to speak up.

**Recruitment of new judges** was first up. Most Feds are always on the lookout for new judges. A general conclusion was that younger people are not as readily available for either this, or even to join clubs, due to pressures of work, travel and family commitments. It was accepted that judges who were not members of clubs could still be listed although a number of Feds require judges to be members of a "bona fide" club. Inter-fed transfers were usually listed in the new Federation immediately, but some were required to attend the next training session available.

**Classification of judges** was next. Some Federations have only one combined list, while others have carefully managed lists A, B and C style classification. Promotion up and down the classes was done by some, but this is seen as difficult to introduce where it is not already an established practice.

**Re-training and development** was an interesting subject covering a wide variety of approaches. Some Feds do very little because the judges who needed it most were the ones who would not attend. Others had planned development and, in some cases, development sessions are mandatory for promotion to the next level. "Accreditation", awarded, for example, after attendance a development forum, could be a means of introducing a new class or a promotional route. It was proposed that visits to PAGB exhibitions and Salons should be "enforced", but this was met with concern about the "breadth" of photography selected for these events. It was mentioned that the some of "best" judges were those with a wider exposure to the Arts, and so visits to more general exhibitions seemed acceptable. Mandatory attendance at any prescribed development forums or refresher seminars could be a way of retaining judges on lists, or de-listing them.

**Feedback and Complaints about judges** was bound to come up and a long discussion followed. It covered the setting of standards for judges through to controlled feedback forms along with the validity of a complaint and what was best done with the information. We agreed that different judges have different qualities and different clubs have differing requirements. In the end it was agreed that the matter was self-regulating because clubs could choose not to re-invite. It is a data protection requirement that written feedback forms and complaints need to be available to the judge if he/she asks (see PAGB web for details) but more importantly the meeting felt that any feedback should be given to the judge for self-improvement and development purposes. We wondered if we might be able to come up with a "Best Practice" for judging or a standardised "rating" method, but it looked like the vagaries of judges and clubs' opinions will make this too difficult.

**Appointment to the PAGB list.** More PAGB judges are needed now and this attracted the question of how Feds should select candidates. Rod clarified by suggesting that Federation committees ask "is this judge as good as or better than many of those already on the PAGB list?" Rod also clarified the purpose of the PAGB list, as "those judges whom the PAGB will call upon to judge at PAGB events". Obviously appointment to the PAGB list carries a prestige and other exhibitions and organisations may well look to use them. It is implicit that these judges are fully familiar with the standard of PAGB competitions and exhibitions and capable of doing well in them themselves. It was noted that Exhibitions requiring PAGB Patronage are now required to have 2 judges from the PAGB Approved List or, with PAGB agreement, judges of similar quality.

**Complaints about clubs** for their handling of judges was not reported as being as bad as some might have expected. Some Federations are introducing feedback forms about clubs. This, like complaints about judges was thought to be self-regulating.

**Scoring ranges and maximum number of images to present to a judge** came up but it was generally agreed that no general rules can be set and it was up to the club and the judge to reach agreement at the time of booking.

**At the end of the meeting** it appeared that everyone got something out of it, the discussion had been informative and most participants had picked up at least one new idea to take back to base.

# The KCPA Ross Cup 2015


The Ross Cup has been an important part of the photography calendar of Kent since 1951 and is always a closely fought competition amongst the 40 or so clubs in the federation.
